Business and Professional License Classifications

Section 7.9

License Fee and Tax

Every person or business subject to licensure under the ordinance shall be assessed and required to pay annually:

- (a) A fee for the issuance of such license in the amount of \$30.00 minimum
Or,
- (b1) For **Contractors** and person constructing for their own account for sale, 14 cents per \$100.00 of gross receipts.
- (b2) For **Retailers**, 16 cents per \$100.00 of gross receipts.
- (b3) For **Financial, Real Estate and Professional Services**, 15 cents per \$100.00 of gross receipts.
- (b4) For **Repair, Personal and Business Services** and all other business and occupations not specifically listed or exempted in this ordinance or otherwise by law, 07 cents per \$100.00 of gross receipts.
- (b5) For **Wholesalers**; 05 cents per \$100.00 of purchases.
- (b6) For **Carnivals, Circuses and Speedways**, \$150.00 for each performance held in this town.
- (b7) For **Fortune Tellers, Clairvoyants and Practitioners of Palmistry**, \$500.00 per year.
- (b8) For **Massage Parlors**, \$500.00 per year.
- (b9) For **Itinerant Merchants or Peddlers**, see Dublin Town Code Article IV Section 7.151 through Section 7.165.
- (b10) For **Photographers** with no regular established place of business in this town, \$30.00 per year.
- (b11) For **Permanent Coliseums, Arenas or Auditoriums** having a maximum capacity in excess of 10,000 person open to the public, \$500.00 per year.
- (b12) For **Savings and Loan Associations and Credit Unions**, \$50.00 per year.
- (b13) For **Direct Sellers** as defined in Section 58.1 – 3719.1 of the Code of Virginia with total annual sales in excess of \$4,000.00, 16 cents per \$100.00 of total annual retail sales or 16 cents per \$100.00 of total annual wholesale sales, whichever is applicable.

Notwithstanding any other provisions of 7(a) and (b) above, those businesses or occupations listed in paragraphs 7(b) 6 through 12, inclusive, shall pay the flat fee cited therein.
